

Previous BMSB season 22/23 summary


- Around 1700 dead BMSB were found with only 44 live confirmed across all
 pathways last season compared to 62 live in the previous season
- Most of the live finds were from passengers and cargo not required to be treated
- No live BMSB were found in <u>offshore treated</u> cargo 2022-23 season so the offshore treatment programme is working well



BMSB 2023/24

- MPI advise that they have completed their annual review on the BMSB seasonal measures. There will be no changes to the Import Health Standards for [<u>Vehicles, Machinery and Parts</u>] and [<u>Sea Containers</u>]
- Both standards include requirements for importing goods to New Zealand during the Brown Marmorated Stink Bug (BMSB) risk season.
- The BMSB season covers all cargo that depart on or after the 1st September and arrive in New Zealand on or before 30th April of every year.



Sealing the container prior to 1 September

- Time stamped photos will be required alongside the final BoL as evidence that a fully enclosed container has been sealed before 1 September and exported (SOB date) before 1 October.
- These documents will need to be uploaded in your import entry.
- Containers meeting this requirement are excluded from BMSB management as detailed in Schedule 3 & Section 2.1(2)(e) of the VMP.all, and Section 3.1.1(4)(a) & 2.1(1)(l) of Seaco.all

Please note – the seal number will need to be clearly visible on the BoL as well as the shipped on board date.

Preparing for uncertainties

- A generic CTO direction will be available for shipments of used vehicle and machinery parts ex Japan where meeting the before arrival treatment requirements are unachievable during the 23/24 BMSB Season.
 - Please remember, FCL of used parts require treatment at VCE1 not VCE1d (VCE1 is a higher rate) year round, regardless of whether the treatment is completed on or offshore.
- A generic CTO direction will be available for shipments which have been sealed prior to 1 September but due to shipping delays, have not sailed prior to 1 October (extension will be limited to 2-3 weeks – yet to be finalised)
- Please get in touch with standards@mpi.govt.nz early if you are experiencing difficulties due to treatment provider availability or shipping delays.

BMSB Treatment Provider Reapprovals



- All treatment providers that intend to continue to conduct BMSB treatments must re-register for 2022-23.
- All registration requests are expected to be completed by 1 September.

- You may notice the look and feel of the offshore approved treatment providers website has changed and those approved for the relevant type of treatment will be accepted for BMSB.

- Certificate address for provider different to that on list
- Location address missing
- Incomplete treatment records
- Treatment did not comply
- Fraudulent certificate
- Treatment information missing

New BMSB Treatment

- There is a **new treatment** with **Ethyl formate** in ABTRT for BMSB and ants.
- Please request this from NZ treatment providers to encourage uptake
- It has less restrictions than MB (no recapture) and is safer

Updates from BCS

- Planning for new season underway; there are no major changes expected for this season
- BCS Verification is likely to remain consistent with last season
- Focus on higher risk categories; cargo from Schedule 3 countries that requires some form of BMSB management.
- Also continue with proactive verification on native range and non-Schedule 3 countries to maintain oversight and respond to any emerging risks as required.

Updates from BCS

Erin McElhannan Team Manager Assurance and Tamsyn Phillips Team Manager Systems Verification

- Vessel risk assessment is conducted prior to arrival
- Crew BMSB reporting sent through by Agent forms part of this assessment
- Accurate and clear crew reporting reduces the likelihood of hold ups on arrival i.e., increased surveillance.
- Verification of new vehicles and machinery continues as an additional assurance method

DTR SEA — Process for BMSB Italian containers

FAK ex Italy

A **DTR request** for FAK containers coming from Italy will initially **be held** and sent to the manual processing queue – Target Evaluation Team.

Attached documentation for example Treatment Certification, or sensitive cargo exemption letters, will be checked by a Target Evaluator.

Note: The QD, BOL, Manifest must still be submitted as well as the above.

If certification conforms, then the DTR request for that container will be approved.

FAK ex Schedule 3 countries

- Lodge your applications as soon as possible to prevent delays.
- If you are aware of an issue, such as failure to treat offshore, engage with MPI as soon as you can.
- For consignments arriving very early in the BMSB season make sure your bill of lading has a shipped on board date if shipped prior to 1 September.
- Urgency requests can be emailed to manifest@mpi.govt.nz. Ensure that you specify the reason for urgency and that it meets our criteria.
